

ORDINANCE NO. 703

AN ORDINANCE AMENDING CHAPTER, 13.60 WATER AND SEWER RATES OF THE HAYDEN MUNICIPAL CODE

RECITALS

Whereas, The Town of Hayden, Colorado (the "Town") is a home rule municipality duly organized and existing under Article XX of the Colorado Constitution and the Town of Hayden Home Rule Charter (the "Charter"); and

Whereas, The Town is the owner of a municipal water and wastewater system (the "System"), which System historically has been operated on a self-supporting basis with its financial operations accounted for in a water and sewer enterprise fund of the Town; and

Whereas, The Hayden Town Council has determined fee adjustments for 2021 are necessary based on a new "meter size" that has been connected to the system and base rates for this meter size (both water and sewer) are currently not adopted and therefore it is necessary to amend 13.60 Water and Sewer Rates of the Hayden Municipal Code updating fees.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HAYDEN, COLORADO:

Section 1. Adoption.


Chapter 13.60 of the Hayden Town Code is hereby amended as follows:

1. Section 13.60.010, B. is hereby changed to reflect the following additional base fee:
 - B. The base rate for water usage is defined below for the specific applications:
 6. The water base rate equals seven-hundred twenty-seven dollars and ninety cents (\$727.90) for a four inch (4") meter, which is equal to (16.67) SFE's.
2. Section 13.60.030, B. is hereby changed to reflect the following additional base fee:
 - B. The monthly base rate for sewage usage is defined below for the specific application:
 6. The sewer base rate equals three hundred forty dollars and fifty-three cents (\$340.53) for a four inch (4") meter, which is equal to (16.67) SFE's.

Section 2. Severability. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.


Section 3. Effective Date. This Ordinance shall be in full force and effective immediately on April 1, 2021.


