

ORDINANCE NO. 707

AN ORDINANCE AMENDING CHAPTER, 13.80 KEY PUMP WATER CUSTOMERS OF THE HAYDEN MUNICIPAL CODE

RECITALS

Whereas, The Town of Hayden, Colorado (the "Town") is a home rule municipality duly organized and existing under Article XX of the Colorado Constitution and the Town of Hayden Home Rule Charter (the "Charter"); and

Whereas, The Town is the owner of a municipal water and wastewater system (the "System"), which System historically has been operated on a self-supporting basis with its financial operations accounted for in a water and sewer enterprise fund of the Town; and

Whereas, The Hayden Town Council has determined fee adjustments for 2021 are necessary based on a new bulk water system installation, historical usage in the calculation water meter rates, and capital cost charge to fund, properly repair, maintain and operate the bulk water system and therefore it is necessary to amend 13.80 Key Pump Water Customers of the Hayden Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HAYDEN, COLORADO:

Section 1. Adoption.

Chapter 13.80 of the Hayden Town Code is hereby amended as follows:

1. Chapter 13.80 Key Pump Water Customers is amended as follows:

Bulk Water Customers

2. Section 13.80.010 Key Pump Water Customers Security Deposit is hereby deleted.

3. Section 13.80.020 Metered Rate is hereby amended as follows:

The metered rate for water delivered to bulk water users shall be computed using \$0.0200 per gallon of metered usage.

4. Section 13.80.030 Capital Costs is hereby amended as follows:

13.80.030 Technology Service Fee

There shall be a technology service fee of \$0.0017 per gallon to offset technology costs of the bulk water system, in addition to the metered rate.

5. Section 13.80.040 One Time User Fees is deleted.

6. Section 13.80.050 Loss of Key is deleted.

7. Section 13.80.060 Payment – When Due is amended as follows:

The user fees establish shall be payable at time of usage. A user may go on-line to the application/database and set up a self-maintained account to establish multiple users and restrict or limit usage per user.

8. Section 13.80.070 Disconnect – Failure to Pay Charges is amended as follows:

13.80.070 Collection – Failure to Pay Charges

Failure to pay due to fraud, stolen card or tampering with equipment will be collected through the fullest extent of the law.

Section 2. Severability. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 3. Effective Date. This Ordinance immediately on final passing and adoption, shall be in accordance with Section 3-3h of the Hayden Home Rule Charter and recorded in the Town Book of Ordinances kept for that purpose, authenticated by the signatures of the Mayor and attested by the Town Clerk. This Ordinance shall be in full force and effective immediately on June 3, 2021, in accordance with Section 3-3h if the Hayden Home Rule Charter.
