Special Meeting Hayden Economic Development Commission August 2, 2022

The special meeting of the Hayden Economic Development Commission was called to order by Christy Sinner, Commission Chair at 6:05 p.m. Other members present at roll call were Commissioners Kevin Booth, Kathy Coates, Caroline McClenahan, and Trevor Gann. Community Development Director, Tegan Ebbert, and Best and Brightest Fellow, Allesha Beaulieu, was also in attendance.

ROLL CALL Attendance as noted above.

OLD BUSINESS

2022 HEDC Plan – Strategy and Projects Milestones Update Tegan Ebbert and Allesha Beaulieu provided milestone updates on the Hayden Economic Development Commission 2022 Work Plan.

Business Pitch Competition Discussion and Planning Tegan Ebbert and Allesha Beaulieu outlined the current plan for the 2022 business pitch competition. The competition will take place in Fall of 2022. Staff recommends hosting the competition in November which will allow participants that applied for the SCORE Business Plan Competition to also submit applications for the Business Pitch Competition. Staff recommends the next regular meeting be largely dedicated to planning for the business pitch competition. Christy Sinner suggested that a 2021 winner might help support the promotion of the 2022 competition.

NEW BUSINESS

Review and Consider Approval of Franciosi Brothers Economic Incentive Request Tegan Ebbert reviewed the Economic Incentive Requests and recommends awardees should share information, held in confidence, about their businesses well-being in the future to enable the Town to better understand the opportunities and challenges that local business owners in Hayden experience.
