Staff & Councilmember Reports

HAYDEN CENTER

Sarah Stinson, Director Arts and Events: In January, we applied for a grant out of Steamboat Springs and it went well. They will come to tour our facility in April and we will know more about the grant in April. We are outfitting arts section, kitchen, signage, arts and supplies. Finalizing programming for summer camp dance class and instructor for the pottery studio. Hayden Center Grand Opening schedule for May 15, 2024.

Rhonda Sweetser, Director Parks and Recreation: Hayden Parks and Recreation Board chose to cancel the annual egg hunt due to weather and will approach next year with an inside venue at the Hayden Center. Beginning organization for Pee Wee wrestling, and getting fish for Huck Finn Days. Ten highschoolers came to Hayden Center and helped out as part of their community outreach. It was quiet at Hayden Center due to spring break. The new system is up and running and will be beneficial for users and staff. T-ball is in April. Soccer after baseball and softball.

POLICE

Chief of Police Scurlock:

PUBLIC WORKS

Bryan Richards, Public Works Director: Today met with Routt County Emergency Management we were considered above average and Hayden is preparing, should it occur again. Sand bag stations have been set up at the Police Station and 4th Street and Washington Street. This will probably be an annual preparation. Routt County is working on the drainage (Dry Creek Village); Last week County Commissioners approved transferring ownership of RCR 51 now owned by Hayden. Sage Creek Project winding down; culverts are in and some minor things need completion; Sage Creek Trail should be open soon. North 5th street paving will be started the first couple weeks of May. State of Colorado has new regulation, no lead or copper infrastructure from main to house; state requires inventory of all infrastructure. Sunrise Engineering has grant and ability to record inventory to ensure no lead or copper pipes. Lake Village was after lead pipes were allowed, so they are eliminated. Town will be able to use a hydrovac to verify lead and copper pipes (6inch hole), then use a tool to replace. Public Works and the town will survey this spring. Street sweeping begins and looking at potholes to cut and repair. Starting Walker Ditch Headgate project. CU Boulder working on the project; Dry Creek Village and Hayden Valley School downstream and use the water.

PLANNING

Tegan Ebbert, Community Development Director: Planning has had a few weeks of grant writing. Over past several weeks we have seen several development inquiries for our annexed undeveloped property. Anticipating the Prairie Run will be on next week's agenda. We made the decision on the Hayden Farmer's Market; current organizer was going to only do one a month for four months. The town is going to hire a market coordinator and have it as a gathering vent and low cost for small entrepreneurs. The market coordinator will work 10 hours a week and nine weeks, every Thursday in June and July and

first two weeks in August, minus July 4th. Town could have a booth and councilmembers or boards and commissions could be available.

General Fund annual budget sales tax received and building use tax budget and both were above budgeted amount. General Fund 120% collected on budget. General Fund is starting to draw back on pulling on grants. Administrative expenses are over budget from the flood and did not know if funds would come in from the state. Reviewed each of the fund departments and at the end at 117%, placing us over by 17% with the flood expenses. Added an unexpected position. The Hayden Center was at 102% of budget with the project. Capital Improvement Fund holds funds until projects are proceeding forward. Water and Sewer Department were at or under budget. End of year financials. The authority is in planning stages and must go to ballot and a tax that is for supporting the cost must be on the ballot. Along with the question to create the authority. There has to be money for engineering and Hayden said yes to the collaboration, in portion to the size of the community. They are looking at a Routt County sales tax. Mathew Mendisco, Town Manager, received two separate grants 1m for Northwest Colorado Business Park and 2M for Prairie Run sidewalk project linking the sidewalk from Prairie Run to 6th Street. Operationally the Hayden Center is pretty much completed. Staff requested that the April 18th meeting be cancelled and schedule another meeting the next week. The April 18th meeting was canceled and April 25th is the new scheduled meeting.
