PUBLIC COMMENT

Kevin Copeland 380 S Poplar St.

Questioned if a tax exemption will be given to Prairie Run Development. Chair Banks responded with a partial tax exemption. Kevin is questioning why we are giving this tax exemptions when local businesses are losing. Banks responded with the need of affordable housing. Kevin Copeland questioned the grant that was received. Banks responded with it being from DOLA. Kevin questioned the interest rate that is given.

Kevin also asked if sidewalks would be installed and if the development would be responsible for the sidewalk and infrastructure. Kevin also questioned if Town of Hayden is becoming a bedroom community to Steamboat. Commissioner Gann interjected that we have fallen from the object of Public Comment. Chair Banks recognized that there should not have been banter during protocol of a Public Comment process.

Carlson clarified that the loan is grant money from the state. The developer is repaying the Town of Hayden with 1% interest. The Town applied for the grant and was awarded the money.

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR THE FUND AND ADOPTING A BUDGET FOR THE HAYDEN HOUSING AUTHORITY FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2025 AND ENDING ON THE LAST DAY OF DECEMBER 2025

RECITALS

- 1. The Town Council for the Town of Hayden Per resolution 2021-09 created the Hayden Municipal Housing Authority (the Authority) to help with the affordable crisis in Hayden, CO.
- 2. The Commissioners of the Authority must adopt an operating budget prior to each fiscal
- 3. A proposed budget for fiscal Year 2025 was prepared prior to the date hereof and is attached hereto as Appendix A
- 4. Upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, and a public hearing was held on December 5, 2024, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget.
- 5. Whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE HAYDEN MUNICIPAL HOUSING AUTHORITY AS FOLLOWS:

Section 1. That the budget as submitted, amended and summarized by fund, hereby is approved and adopted as the budget of the Authority for the year 2025 subject to final assessed value and final staff changes to be submitted to the Department of Local Affairs on or before January 31st, 2025.

Section 2. That the budget hereby approved and adopted shall be signed by the Chair of the Authority and made a part of the public records of the Authority
