RE: Quasi-Judicial Decision Making and Ex Parte Communications

It is important to the integrity of the Town's making process that decision-makers understand the nature of the various decisions that they are called upon to make, and the potential legal consequences if those decisions are not made in accordance with legal standards, both procedural and substantive. Tow issues that often arise in the course of planning and land use decision-making are the nature of quasi-judicial decision making and *ex parte* communications during the course or in the context of that decision-making process. I have prepared this memorandum on these subjects to assist you in considering these issues as they arise in the future.

I. Quasi-Judicial Decisions

A "quasi-judicial" decision is a decision that involves the application of existing legal standards to a particular property or application to use property in a way that affects the property rights of one individual (the owner), but not others. The Town Council makes quasi-judicial decisions when it considers subdivision applications, rezoning applications, site plans and other similar site-specific land use or development applications. These sorts of decisions should be thought of as distinct from "legislative" decision-making, which is the making of decisions about the adoption or modification of laws and regulations of general applicability; being laws that apply equally to all similarly situated properties or individuals. Most of the time, a Town Council is engaged in legislative decision making, but sometimes engages in quasi-judicial decision-making.

From a legal standpoint, the primary differences between a "legislative" and a "quasi-judicial" decision is process under which the decision is required to be made, and the standard under which the decision will be judged by a court of law if challenged.

Legislative decisions are usually not required to be made after a public hearing (only in a meeting that is open to the public), and usually do not require any particular process before they may be made (other than the adoption of an ordinance). Typically, "legislative" decisions can only be legally challenged as be "ultra vires" (beyond the legal authority of the legislative body to have adopted) or as a procedural or substantive due process violation (meaning, usually, that a

person claims that the law unconstitutionally discriminates against them) These sorts of challenges to legislative actions can be the topic of a future work session, but suffice to say that in making legislative decisions, the Town Council has very broad discretion, that is generally limited only by the federal or state constitution, state laws, or the Town Charter.

A quasi-judicial decision, on the other hand, generally must be made only after a public hearing for which notice has been provided under law. In making a quasi-judicial decision, the Town Council applies an existing set of legal standards to a given application (which is usually in the context of land use, but also occurs in licensing decision, such as liquor licensing). A quasi-judicial decision is not given the broad deference by courts that a legislative decision enjoys. Instead, a quasi-judicial decision is subject to challenge under an "arbitrary and capricious" standard that is set forth in Colorado Rule of Civil Procedure 106(a)(4) and defined by the case law of Colorado.

Under Colorado case law, a decision is not "arbitrary and capricious" if it is supported by "competent evidence on the record" that was before the decision-making body. In turn, "competent evidence on the record" has been defined to mean enough evidence to make the issue at hand "fairly debatable" by reasonable people. There need not be a "proof beyond a reasonable doubt" nor even a "preponderance of evidence" in support of a given proposition to meet the competent evidence standard. In this sense, the arbitrary and capricious standard is somewhat deferential to the decision making body.

It is not without its limits, however. To be upheld on appeal to a court, a quasi-judicial decision must express its findings of fact as they relate to the criteria or standards under which the decision is made, and those criteria or standards must be sufficiently specific to avoid a challenge on grounds of vagueness. In other words, those standards must be specific enough to give a property owner reasonable notice of what will or will not be allowed in terms of the use or development of a particular piece of property.

In making a quasi-judicial decision, the Town Council (or Planning Commission, depending on the decision being made) is expected to take on the role of a judge. The individual Councilors are expected to come to the decision-making process without any bias as to the outcome of the proceeding and are to make their decision based only on the evidence presented to them in the hearings held concerning the matter as it relates to the legal standards for making the decision.

The reason for the rule as to bias is that constitutional "due process" requires an unbiased decision-maker (one without what the case law describes as "pre-judgment bias"). The reason for the rule as to the making of a decision based only on evidence presented at a hearing is two-fold. First, constitutional "due process" requires that the parties to a proceeding (be they an applicant or community member) must have the opportunity to rebut or otherwise respond to whatever arguments may be made to a decision-maker concerning the matter at issue. The second is that, because a court in reviewing a quasi-judicial decision must determine whether the

decision is supported by competent evidence on the record, the court expects that all matters that were considered in making that decision be a part of the record of the proceedings.

II. Ex Parte Communications.

An ex parte communication is a communication made to a decision-maker, outside of a public hearing and not on the record, by a party to a transaction (such as an applicant or member of the community). Ex parte communications are not in and of themselves illegal, or unethical. However, ex parte communications are not fair to anyone who is not a party to them, and they can also adversely affect the very result which the decision-making body seeks to cause. (Meaning that they can cause a court to overturn a decision of the Town Council.)

Ex parte communications typically arise when either developers or development opponents contact Planning Commissioners, City Councilors or Board of Adjustment members in advance of a hearing, to explain their position, offer comment, criticize the other side's position, seek a "reading" on what the decision-making board might think about a particular issue, etc.

Reliance by the decision-making board, or a member thereof, on any ex parte communication taints the hearing process. This is because ex parte communications are made without notice to the other side. They are therefore, by definition, unfair to the other side, because they do not afford the other side an opportunity to respond. In conducting a hearing, the decision-maker may not consider ex parte communications without giving notice thereof to all parties. See Hartley v. City of Colorado Springs, 764 P.2d 1216 (Colo. 1988); Whelden v. Board of County Commissioners of Adams County, 782 P.2d 853 (Colo. App. 1989); Sclavenitis v. City of Cherry Hills Village Board of Adjustment and Appeals, 751 P.2d 661 (Colo. App. 1988). Ex parte communications are particularly insidious because they do not form a part of the record and therefore their effect on the decision-making process cannot be measured or ascertained.

A council or planning commission or board of adjustment must conduct its consideration of land use matters in a manner which affords all of the parties due process. This means that fairness to all parties must be maintained. Sclavenitis, supra. The applicant in any land use decision is clearly a party in interest. However, other landowners adjacent to or near the property which is the subject of the land use decision are also parties in interest and have a right to be heard. Snyder v. City Council of the City and County of Denver, 531 P.2d 642 (Colo. App. 1975).

Over years of representing municipalities, I have consistently advised planning commissions, councils and boards of adjustment making land use decisions to strongly discourage all ex parte communications. Individual members should not engage in conversations or meetings with developers or citizens to discuss a matter which will be before the planning commission, council or board of adjustment for decision after a public hearing. Rather, all interested parties should routinely be referred to the staff so that the staff may incorporate their comments into the

publicly circulated staff report. All persons should also be encouraged to attend the hearing and to express their views at the hearing. Again, the rationale for this is that publicly expressed views will be heard by all, and any parties in interest with opposing views will have the opportunity to make their objections known in the public forum.

There are, of course, occasions when an ex parte communication cannot be avoided. In such cases, the recipient of the ex parte communication should always announce, at the hearing, the nature, source and content of the communication. Again, the purpose of this is to make the communication public, and to afford all parties in interest the opportunity to make comment on it. It also affords all of the other members of the decision-making body the opportunity to consider the same information made available to an individual member.

In conclusion, I realize that councilors, planning commissioners and members of a board of adjustment are subjected to pressures in this area. However, if a decision-maker wants to preserve the effectiveness of his or her vote, that decision-maker should never engage in conduct which could risk that person's vote being negated, and perhaps even the very decision which the decision-maker supported being overturned.

RE: Ethics in Government – Conflicts of Interest and Related Ethics Issues

Questions concerning conflicts of interest and related ethics issues arise with some frequency in the context of governmental decision-making. In Hayden, the conduct of governmental officials is governed by state statutory provisions found at Title 24, Article 18 of the Colorado Revised Statutes (C.R.S.) titled "Code of Ethics". I have prepared this memorandum on the principal provisions of the state statutes to assist you in considering these issues as they may arise in the future.

I. Conflicts of Interest – State Statutory Prohibitions

Section 24-18-109 of the Colorado Revised Statutes sets out rules of conduct for local government officials and employees. Among other things, it prohibits local government officials from:

Perform[ing] an official act directly and substantially affecting to its economic benefit a business or other undertaking in which he either has a substantial financial interest or is engaged as counsel, consultant, representative or agent.

C.R.S. § 24-18-109(2)(b).

Along similar lines, Section 24-18-109(2)(a), C.R.S., prohibits a local government official or employee from "engaging in a substantial financial transaction for his private business purposes with a person whom he inspects or supervises in the course of his official duties. Likewise, Section 24-18-109(2)(c) prohibits, except under limiting circumstances, a public official or employee from accepting goods or services from a person who at the same time provides good or services to the public entity that the official or employee serves.

This statute is mandatory, and violations of the statute are proof that the actor "has breached his fiduciary duty and the public trust." In turn, that breach can create monetary liability on the part of the actor under Section 24-18-103, C.R.S. In addition, the result of votes

which reflect a conflict of interest by any one member are voidable, even though the vote of that particular member may not have been a deciding vote.

Other, significant limitations on elected officials' and public employees' activities that are related to conflicts of interest are contained in Section 24-18-104, C.R.S. Those limitations include:

- 1. A prohibition on disclosure or use of confidential information acquired in the course of the actor's official duties in order to further substantially a personal financial interest; and
- 2. A prohibition on the receipt of gifts of substantial value or the receipt a substantial economic benefit that is tantamount to a gift that would tend to improperly influence a person to depart from the faithful and impartial discharge of his public duties.

II. Conflicts of Interest – What to do if you have one (or think that you may have one)?

Under Section 24-18-109(3)(a), if a member of a governing body has a conflict of interest (a personal or private interest in a matter proposed or pending before the body) the member must:

- 1. Disclose the interest to the governing body;
- 2. Not vote on the matter ("recuse" oneself); and
- 3. Not attempt to influence the decision of the remaining members of the body on the matter.

If a Council member is uncertain as to whether a conflict of interest exists, I highly recommend that the member first talk with the Town Manager about the issue, as managers tend to have addressed conflicts of interest questions through their service to decision-making bodies. If the Town Manager is not certain about the issue, I recommend inquiring of the Town Attorney. Because conflict of interest questions can be complicated and involve a wide variety of factual scenarios, it is not at all uncommon for councilors or managers to call upon a town attorney for an advisory opinion.

In considering whether to seek counsel about a potential conflict of interest, it is important to remember that there is nothing at all wrong or improper about having a conflict of

interest. Such conflicts can and do arise as a result of a Council member's employment, or the ownership of certain property, or any number of other perfectly appropriate situations or circumstances (particularly in smaller towns). What is wrong and improper is to participate in governmental decision-making when the decision-maker has a conflict of interest.

III. Conclusion.

I hope that all of the foregoing is helpful to you as you consider matters that involve, or potentially involve, conflicts of interest in the governmental decision-making process. Because your consideration of such matters is vitally important to the public's trust in its elected officials, I very much encourage you to inquire of me or the Town Manager whenever you are faced with a situation that may involve a conflict of interest.

RE: Colorado Open Meetings Law

One state statute that all local government officials should be aware of is the Colorado Open Meetings Law (§ 24-6-401 *et seq.* C.R.S.). I have prepared this memorandum on that law to assist you in considering issues as they arise in the future.

The Colorado Open Meetings Law contains as its "Declaration of Policy" that:

It is declared to be a matter of statewide concern that the formation of public policy is public business and may not be conducted in secret.

The Colorado Supreme Court has described the Open Meetings Law as "reflect[ing] the considered judgment of the Colorado electorate that democratic government best serves the commonwealth if its decisional processes are open to public scrutiny." *Benson v. McCormick*, 578 P.2d 651, 653 (Colo. 1978).

The purpose of this memorandum is to answer the most common questions concerning the requirements of the Open Meetings Law, including:

- 1. Who is covered by the law?
- 2. What is a "meeting?"
- 3. When are "executive sessions" permitted?
- 4. What happens when the law is violated?

1. Who is covered by the law?

The operative provision of the Open Meetings Law states that "All meetings of a quorum or three or more members of any local public body, whichever is fewer, at which any public business is discussed or at which any formal action may be taken are declared to be public meetings open to the public at all times." § 24-6-402(2)(b) C.R.S. In turn, the statute defines a "local public body" to include any board, committee, commission or other policymaking, rulemaking, advisory or formally constituted body of a political subdivision of the state, such as a municipality. § 24-6-402(1)(a), C.R.S. However, "persons on the administrative staff" of a local public body are specifically excluded from the definition of a "local public body."

2. What is a "meeting?"

The statute broadly defines a "meeting" as "any kind of gathering, convened to discuss public business, in person, by telephone, electronically, or by other means of communication." In a recent case, the Colorado Supreme Court explained that for a gathering to be subject to the Open Meetings Law requirements "there must be a demonstrated link between the meeting and the policy-making powers of the government entity holding or attending the meeting." *Board of Commissioners of Costilla County v. Costilla County Conservancy District*, 88 P.3d 1188, 1194 (Colo. 2004). This holding is consistent with the provision of the Open Meetings Law that provides that the Open Meetings Law "does not apply to any chance meeting or social gathering at which discussion of public business is not the central purpose." § 24-6-402(2)(e), C.R.S.

In response to technological advances, in recent years the General Assembly amended the Open Meetings Law to include "electronic" as well as "other means" of communication under the statutory definition of a "meeting." At the time of this writing, no reported Colorado case has discussed the requirements of public notice of an "e-mail" meeting, or the way in which an interested member of the public might be privy to such a "meeting." Many municipal attorneys presume, however, that a serial e-mail that travels between three or more members of a local public body and discusses public business may well constitute a "meeting" for which public notice must be given.

3. When are "executive sessions" permitted?

Because the underlying principle of the Open Meetings Law is that the formation of public policy is public business, and therefore cannot be conducted in secret, the exceptions to the statute are limited and strictly tailored to situations where the General Assembly has determined that private discussions could serve the public interest. The statute limits private meetings, referred to "executive sessions" to the following situations:

<u>Real and Personal Property</u>: An executive session may be held to discuss the purchase, acquisition, lease, transfer, or sale of property interests, so long as the executive session is not held to conceal an official's personal interest in the property. § 24-6-402(4)(a), C.R.S.

Attorney Conferences: Although the mere presence of an attorney does not justify the executive session, the governing body may call an executive session for the purpose of receiving legal advice on specific legal questions. § 24-6-402(4)(b), C.R.S.

Confidential Matters Under State or Federal Law: If any state or federal law requires confidentiality of a particular matter to be discussed, an executive session may be called. When announcing that it will go into an executive session for this purpose, the governing body must announce the specific statutory citation or rule that requires the confidentiality of the matter to be discussed. § 26-4-402(4)(c), C.R.S.

<u>Security Arrangements or Investigations</u>: The specialized details of security arrangements or investigations may be discussed in an executive session. § 24-6-402(4)(d), C.R.S.

<u>Negotiations</u>: A governing body may call an executive session to determine positions relative to matters that may be subject to negotiations, to develop a strategy for negotiations, or to instruct negotiators. § 24-6-402(4)(e).

<u>Personnel Matters</u>: Personnel matters may be discussed in an executive session. However, if the discussion involves a particular employee, that employee must receive advance notice and may insist that the discussion be held in an open meeting. Also, by definition, a "personnel matters" does not include discussions of any member of a local public body, any elected official, the appointment of any person to fill a vacancy in a local public body or elected office, or discussion of personnel policies that do not require the discussion of particular employees. § 24-6-402(4)(f)(I) and (II), C.R.S.

<u>Documents Protected Under the Open Records Law</u>: Discussions of documents protected under the mandatory non-disclosure provisions of the Open Records Act may be held in an executive session. However, discussion of documents protected under the "work product" or "deliberative process" privileges in the Open Records Act must occur in an open meeting unless an independent basis for an executive session concerning such documents exists. § 24-6-402(4)(g), C.R.S.

The statute also contains detailed provisions concerning the procedure for calling an executive session. Before going into an executive session, the governing body must first announce the topic of discussion, including a specific citation to the section of the Open Meetings Law that authorizes consideration of the announced topic in executive session, as well as "identification of the particular matter to be discussed in as much detail as possible without compromising the purpose for which the executive session is authorized." § 24-6-402(4). An executive session may be held only after an affirmative

vote of two-thirds of a quorum present at the meeting. <u>Id</u>. These procedures are of particular importance as The Colorado Court of Appeals has held that failure to comply with the procedural requirements can result in an executive session not being convened. Instead, the session is simply a part of the *open* meeting, and the record of such session is open to public inspection under the Colorado Open Records Act. *Gumina v. City of Sterling*, 119 P.3d 527, 532 (Colo. App. 2004).

4. What happens when the law is violated?

The underlying goal of the Open Meeting Law is to create an atmosphere of openness in public matters, not to "punish" those who violate its provisions. In keeping with that philosophy, the Open Meetings Law contains no criminal sanctions for non-compliance. However, any action taken at a meeting that does not comply with the Open Meetings Law requirements is void. § 24-6-402(8), C.R.S. Courts may also enforce the requirements of the Open Meetings Law through an injunctive order. § 24-6-402(9), C.R.S. Of course, the most serious problem that can arise from an Open Meetings Act violation is the loss of confidence in the government that can arise when official actions are invalidated because laws aimed at assuring open government are violated.

In addition, after an *in camera* review of an executive session record, the court may make public any portions of the record that reveal the body getting substantially off topic or engaging in unlawful decision-making while in executive session. § 24-72-204(5.5) C.R.S.

Finally, if the court finds that a public body has violated the Open Meetings Law, it *must* award the prevailing citizen's costs and reasonable attorney fees. <u>Id.</u> A prevailing public body, on the other hand, may only be awarded its costs and attorney fees if the court finds that the action was frivolous, vexatious, or groundless. § 24-6-402(9), C.R.S.

In conclusion, I would appreciate your noting the fact that Colorado courts have not been called upon to examine many aspects of the Open Meetings Law. Accordingly, judicial guidance when interpreting the statute is somewhat limited. This memorandum is intended to serve as a guide to some of the more fundamental aspects of the law, and I very much encourage you to consult with the Town Manager or me concerning specific questions that may arise from time to time. As always, I am happy to answer any questions or discuss further any of the issues addressed in this memorandum.

COUNCILMEMBER REPORT AND UPDATE

Thad Renaud delivered a Memo and Explanation of Ex Parte Communication; His main point was to do everything possible to avoid the conversations that could put Councilmembers at risk of Ex Parte Communications. BASIC APPLICATION FEES: The Basic Application Fees listed shall be paid in full at the time of application. An application will not be deemed and scheduled for review until the Basic Application Fee has been paid in full. The Basic Application Fee is designed to cover basic filing, inspection, publication and processing costs. It also includes the minimum amount of staff time typically required for an application of that type.

HOURLY FEES: Hourly Fees will be charged for staff time not covered by the Basic Application Fees. Staff time will be charged at a minimum rate of **\$105 per hour.**

ADDITIONAL FEES: Additional Fees may be charged at the discretion of the Town Manager for professional consultants, special research/analysis or when deeed necessary and resonable based on the nature and character of the review required or where unusual issues are presented which may require additional review. Fees for independent consultants and studies may include an additional 15% administrative charge.

RENEWAL FEES: 50% of the Basic Application Fee will be charged to process renewals that are authorized under the original conditions of approval.

AGREEMENT FOR PAYMENT: Applicants shall submit an Agreement for Payment of Development Review Expenses in a form approved by the Town Manager and the associated deposit identified therein concurrently with application materials as such is required as noted below.

APPROVALS CONTINGENT ON FULL PAYMENT OF ALL APPLICABLE FEES: This includes any and all Basic Application Fees, Hourly Fees, Surcharges and/or Additional Fees. Approvals with outstanding balances that exceed 35 days may be deemed null and void.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE TOWN OF HAYDEN AND ROUTT COUNTY FOR THE EMERGENCY USE OF FACILITIES

This Intergovernmental Agreement ("IGA") is made and entered into effective this ____ day of December, 2024, by and between the Town of Hayden, a Colorado home rule municipal corporation, hereafter "Town", and Routt County, a Colorado statutory county, hereafter ("County").

WHEREAS, Part 2 of Article 1 of Title 29 of the Colorado Revised Statutes, as amended, authorizes and enables governments of the State of Colorado to cooperate or contract with one another to provide any function, service, or facility lawfully authorized to each of the cooperating or contracting governments; and

WHEREAS, the parties are each political subdivisions of the State of Colorado and are authorized by the Constitution and statutes of the State of Colorado to provide law enforcement and communication services to their respective citizens and to maintain and operate facilities to support the provision of said services; and

WHEREAS, the Town owns and operates the Hayden Police Department ("HPD") located at 249 Hawthorne St., Hayden, CO 81639; and

WHEREAS, the County operates the Routt County Communications Department ("Dispatch") at the Combined Law Enforcement Facility (CLEF) in Steamboat Springs, which provides emergency dispatch services to various law enforcement, fire, and other service providers throughout Routt County; and

WHEREAS, the parties agree that it would be mutually beneficial to the parties and the citizens of Routt County that Dispatch be provided the ability to utilize HPD facilities during emergent events or as otherwise mutually agreed by the parties.

NOW, THEREFORE, IT IS AGREED by and between the parties hereto as follows:

SECTION 1. FACILITIES. Dispatch will be provided the ability to use the areas shown on the attached Floor Plan. The dates and times of use will be communicated between Dispatch managers and the Hayden Police Chief on an as-needed basis, however, the Chief shall have ultimate authority over the use of the Facilities. Facilities do not include equipment used by Dispatch other than chairs, desks, or other general office amenities already present at HPD.

SECTION 2. ACCESS. Certified Dispatcher will be provided access to an external key lock box. The lock box contains keys which may be used to enter the __ door. Dispatch supervisors and managers shall ensure the security of all entryways at all times as well as the keys used by Dispatch.

SECTION 3. PARKING. Dispatch employees may utilize open parking spaces at the HPD not otherwise reserved.

SECTION 4. EQUIPMENT. While Dispatch may use general office amenities already present at HPD, the County is solely responsible for the equipment mobilized to HPD by Dispatch to include laptops, computers, and telephones. Damage caused to HPD amenities, including office equipment, shall be subject to the reimbursement provisions below.

SECTION 5. INSURANCE AND WORKERS COMPENSATION. The Town and County each maintain insurance policies for their respective facilities and employees. This IGA is not intended to require any changes in current coverages by either party or impact either parties changes to policies, if any, in the future. County employees shall be covered by County's workers compensation and shall not be considered employees of Town for any reason or purpose.

SECTION 6. REIMBURSEMENT. The parties agree that use of the Facilities, including utilities, as provided herein are for the mutual benefit of the parties and that no further consideration is required. However, County shall reimburse Town for any damage to the Facilities, reasonable wear and tear excepted, resulting from Dispatch's use of the Facilities. Reimbursement for damage will be based on replacement at actual value. The County is not responsible for damage related to weather or forces not in its or its employees' control.

SECTION 7. TERMINATION. Either Party may terminate this IGA upon three (3) days written notice to the other Party. County shall be afforded the opportunity to remove any of its equipment during that time period and County shall thereafter surrender any keys, cards, or other equipment provided by Town for the use of the Facilities.

SECTION 8. NOTICES. Electronic mail to and from the Hayden Police Chief and to and from the Director of Emergency Management shall be deemed sufficient notice under this IGA.

SECTION 9. RELATIONSHIP OF PARTIES; GOVERNMENTAL IMMUNITY. The Parties enter into this IGA as separate, independent governmental entities and maintain such status throughout. No officer, agent or employee of either Party shall be deemed an officer, agent, or employee of the other Party. No term or condition of this Agreement shall be construed or interpreted as a waiver, express or implied, of the immunities, rights, benefits, protections, or other provisions of the Colorado Governmental Immunity Act, §24-10-101, *et seq.*, C.R.S.

SECTION 10. BENEFICIARIES; ASSIGNMENT. This IGA is made for the sole and exclusive benefit of the Parties, their successors and assigns, and is not made for the benefit of any third party. The Parties covenant and agree that they will not assign this IGA, any interest or part thereof or any right or privilege pertinent thereto.

SECTION 11. ENTIRE AGREEMENT. This IGA embodies the entire agreement of the Parties. No changes, amendments or modifications of any of the terms or conditions of this IGA shall be valid

unless reduced to writing and executed by both Parties. This provision notwithstanding, the Hayden Police Chief and the Routt County Director or Emergency Management may work together in such a manner to reasonably carry out the intent of this IGA without further written amendments thereto.
